Notes for Authors

- 1) *Japan Review* is a refereed academic journal open to all authors, and is published annually in July. Manuscripts under consideration for publication are refereed anonymously by scholars whose opinions are solicited by the editors. Articles accepted for submission are subject to editorial revision.

- 2) Manuscripts for *Japan Review* should be submitted as e-mail attachments in Microsoft Word format to jr-editors@nichibun.ac.jp. Manuscripts should not normally exceed 10,000 words. *Japan Review* publishes original articles, research notes and annotated translations of important primary sources. The journal is also interested in receiving proposals for special issues. Manuscripts should follow the format of the *Monumenta Nipponica* Style Sheet, which is available online at http://monumenta.cc.sophia.ac.jp/MN_Style.html, and is used by *Japan Review* with permission. In exceptional circumstances, the editors may accept hard-copy submissions, which should be sent to The Editor, *Japan Review*, International Research Center for Japanese Studies.

- 3) Authors should provide the following information in a cover sheet:
 - a) the title of the submission;
 - b) author's full name, academic affiliation, e-mail address, postal address, telephone and fax numbers;
 - c) biographical details of no more than 250 words;
 - d) an English summary of no more than 250 words and a list of ten key words
